A legislative proposal to reshape Texas' standardized testing system could provide more time for school districts like Austin that are facing a tight timeline to turn around schools that have consecutive years of failing to meet state academic standards. For campuses like Austin's Burnet, Dobie and Webb middle schools — where staff and families learned in late spring that possibly disruptive changes would be coming to those campuses in the fall — an amendment in House Bill 4 could buy a little more time for districts to plan their next moves to improve scores. The Texas House on Tuesday overwhelmingly passed HB 4, which would replace the State of Texas Assessments of Academic Readiness test with three nationally norm-referenced tests, which students would take throughout the school year. The Senate on Wednesday received the legislation, though it had not yet assigned it to a committee. House members approved an amendment by Rep. James Talarico, D-Austin, which would grant school districts an extra year to submit a turnaround plan to the state outlining how they will improve scores. The Austin district is currently being required to submit its plans for its failing middle schools by the end of this school year. "You may have schools in your district that are facing this issue where they just found that they may face this consequence but they're not getting that twoyear period that current law says they should get," Talarico said, adding that this includes Dobie Middle School, a 51-year-old campus in Northeast Austin. The Texas Education Agency annually rates districts' and campuses' academic performance on an A-F letter grade system, and the stakes are high for schools that continue to fail state standards for several years in a row. If a campus receives five consecutive "F" ratings, state law dictates that the Texas education commissioner must either shut down the campus or initiate a state takeover of the district. Austin schools Superintendent Matias Segura told families during meetings this week that he hopes HB 4 will create more flexibility for the district, but cautioned that administrators are still planning to move forward with their current aggressive improvement plans at the three North Austin middle schools. The district's plans include revamping the curriculum, investing \$1.7 million in each school and rolling out a reapplication process for much of the staff members. "In either case, we will have to submit the turnaround plan, and in either case we will have to start the work," Segura told parents at Burnet Middle School on Tuesday. To pass, HB 4 still needs to move through the Texas Senate and Talarico's amendment would have to survive the upper chamber. Segura said he hopes state lawmakers will give districts more time to improve school ratings. "My hope and my prayer is that they do. That they give us more room to actually do the work," Segura said. The TEA requires schools have. Normally, districts have two years to implement the plan, with the hope that by the end of the second year, the school has met state academic standards. This year, the timeline has been truncated because of a pair of lawsuits brought by districts contesting the release of those years' rankings. An appeals court in April, however, allowed the TEA to release the 2023 scores, which were published April 24. State scores for 2024 are still tied up in a legal battle and have not vet been released. The Austin district predicts its three failing middle schools could receive a fourth "F" rating by the conclusion of this academic year. If any of those campuses receives a fifth "F" rating in the 2025-26 school year, it could trigger a state takeover of the whole district. This means schools like Dobie, Webb and Burnet have only one year to implement a turnaround plans to begin this fall. During a call with reporters in April about the release of the 2023 scores, Texas Education Commissioner Mike Morath said districts had raw data, so local officials are able to confidently predict scores. "I would be very angry with my school board right now, if this was a situation that I was in, because I would want to know why they hadn't been clearly communicating with me how well my school was doing," Morath said at the time. The results include assessments in mathematics and reading-language arts (RLA) in grades 3-8, 5th and 8th grade social studies. Alongside the statewide release, individual student STAAR report cards are also available for parents across Texas. By visiting their school district's family portal or TexasAssessment.gov using the unique access code provided by their child's school, parents can access their child's school, parents can access their child answered each question on the test and specific recommendations to support their child's academic growth. This year's results show that reading-language arts proficiency for students varied across grades. While some grades demonstrated improvement, others saw slight declines. Grades 4 and 6 rose by three and four percentage points, respectively. The percentage of students who scored on grade level in social studies held steady, mirroring results from 2023. The 2024 results show declining mathematics and science performance in math has not recovered to pre-pandemic levels, making it clear that recovery will require a sustained effort to improve student outcomes. "Results from the 2024 STAAR 3-8 assessments reveal the significant gaps in mathematics achievement across our schools. While we continue to see progress in other areas - which is a testament to the dedication and skill of our Texas educators - it's clear that math performance is not where students need it to be for success after graduation," said Texas Education Commissioner, Mike Morath. "Pandemic-induced disruptions to learning exacerbated students' difficulties in mastering fundamental math concepts. As a result, we must keep our foot on the gas to intensify efforts in providing targeted interventions and research-based education strategies to ensure that students obtain necessary foundational skills and concepts and achieve the desired academic outcomes not only in math but across all subject areas." 2024 STAAR 3-8 Results To Learn More A more detailed, statewide summary of 2024 STAAR 3-8 results is available on TEA's website.
